We seek Speakers Bureau members who share our Christian faith and our commitment to obeying God's will. We ask that as a member of the Speakers Bureau you keep FMSC in your prayers.

### **Characteristics of Speakers Bureau member:**

A Speakers Bureau volunteer is an individual that has an affinity for FMSC and the values we promote. The ideal speaker will demonstrate a willingness to support and promote FMSC's Christian mission and goals. He/she will have a pleasant and professional demeanor, be proactive in working with host partners, and be comfortable communicating the story of FMSC in front of large and small groups.

### **The minimum responsibilities of a Speakers Bureau member include:**

- Volunteering at a packing session at least once a year.
- Responding to at least 1-2 requests for an FMSC speaker per year.
- Proactively coordinate with Speakers Bureau manager to obtain any materials needed for speaking engagements.
- Attending two of the four FMSC Speakers Bureau yearly trainings.
