I. Usage of MannaPack™ Potato-D

II. Ingredient Statement

INGREDIENTS: Dehydrated Potatoes (Potatoes, Mono- and Diglycerides, Sodium Acid Pyrophosphate, Sodium Bisulfite, Citric Acid, and BHT and/or BHA to preserve freshness), Lecithinated Soy Flour (Defatted Soy Flour, Soybean Lecithin), Sweet Potato Flavoring (Dehydrated Sweet Potato, Salt, Dextrose, Sugar, Natural Flavor, Turmeric, Soybean Oil, Maltodextrin, High Oleic Acid Sunflower Oil, Modified Corn Starch, Brown Sugar, Artificial Flavor, Caramel Color).

VITAMIN AND MINERAL PREMIX: Gum Arabic, Calcium Carbonate (Calcium), Ferrous Sulfate (Iron), d,1-alpha Tocopheryl Acetate (Vitamin E), Niacinamide (Niacin), Zinc Oxide (Zinc), Vitamin A Palmitate (Vitamin A), Thiamin Hydrochloride (Thiamin), Riboflavin, Pyridoxine Hydrochloride (Vitamin B6), Folic Acid, Cholecalciferol (Vitamin D3), Cyanocobalamin (Vitamin B12).

III. Assembly Method & Packaging

Packaged in heat-sealed PET/LLDPE pouches which are packed in corrugated cardboard boxes.

IV. Storage & Shelf Life

Product is best if used within 18 months of production. Prepared food not consumed within 4 hours should be discarded. For remainder of unprepared food, close the opened bag and store in cool, dry place and use within one month.

V. Preparation

Shake the sealed bag to mix well. Using chart, combine desired amount of potato powder with boiled or potable water. Stir well and allow to cool as needed. The maximum servings that should be consumed per day is: 4 servings for <1 year olds, 6 servings for 1-4 year olds, 8 servings for 4+ year olds.
